TAIFLEX Monthly Sales Report – June 2018

Taiflex Scientific co., Ltd. (8039) ("Taiflex"), today announced that consolidated revenue for June 2018 totaled NT\$ 834 million, MoM decreased 2.44%, YoY decreased 13.31%. The revenue of Electronic Materials Industry ("EM") was totaled NT\$ 780 million, MoM increased 14.78%, this month's revenue was a new high in the same period of the previous year, mainly due to the demand for FCCL is heating up, coupled with the new customers and new orders play a benefit, the revenue was better than expected. The revenue of PV Industry ("PV") was totaled NT\$ 51 million, MoM decreased 68.91%, mainly because China's "531" new policies cut subsidies, market demand has shrunk rapidly, resulting in the revenue lower than expected.

The consolidated revenue in 2Q 2018 was NT\$ 2.39 billion, QoQ increased 19.30%, YoY decreased 14.09%. The revenue of EM in 2Q 2018 was 2.02 billion, QoQ increased 25.81%, YoY increased 24.34%. The revenue of PV in 2Q 2018 was 361 million, QoQ decreased 13.02%, YoY decreased 68.50%.
