TAIFLEX Monthly Sales Report - December 2019

Taiflex Scientific co., Ltd. (8039) ("Taiflex"), today announced that consolidated revenue for December 2019 totaled NT\$ 661 million, MoM increased 0.86%, YoY increased 8.79%. The revenue of Electronic Materials Industry ("EM") was totaled NT\$ 633 million, MoM increased 0.44%, YoY increased 24.18%.

The consolidated revenue in 4Q19 was NT\$ 1.96 billion, QoQ decreased 9.86%, YoY decreased 18.70%. The revenue of EM in 4Q19 was 1.88 billion, QoQ decreased 11.20%, YoY decreased 11.20%.

Cumulative revenues of 2019 was 7.58 billion, YoY decreased 21.36%. The revenue of EM was 7.25 billion, YoY decreased 13.44%.
