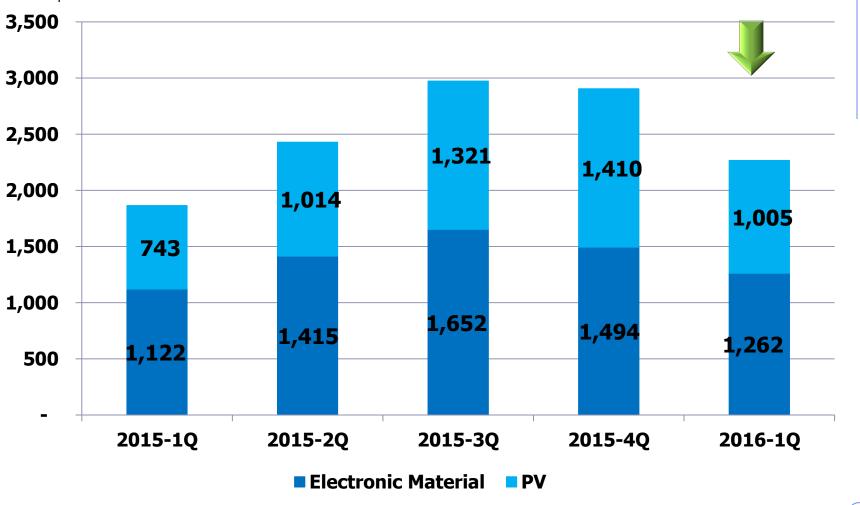

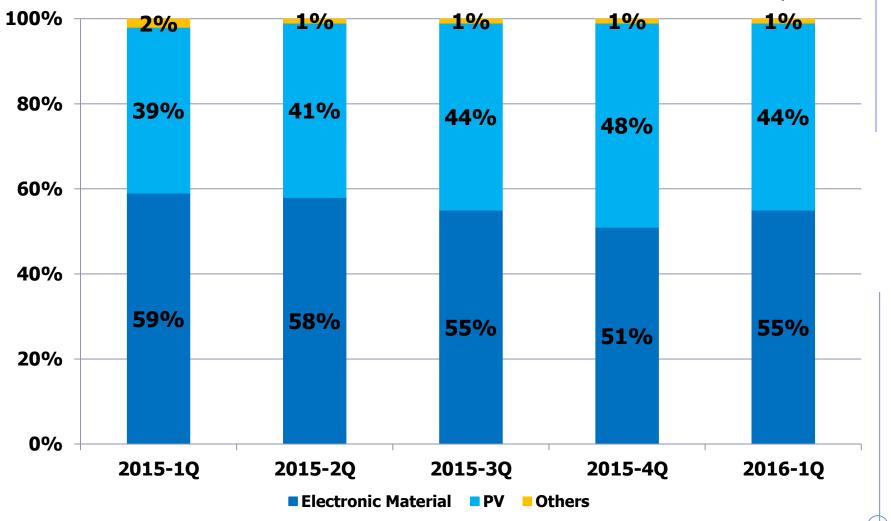
## Sales Breakdown (1/3)

Unit: NT\$Million



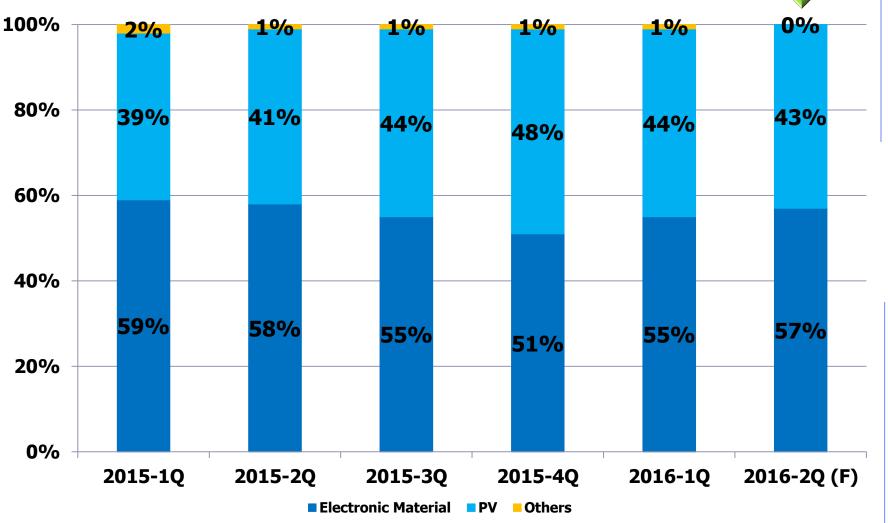

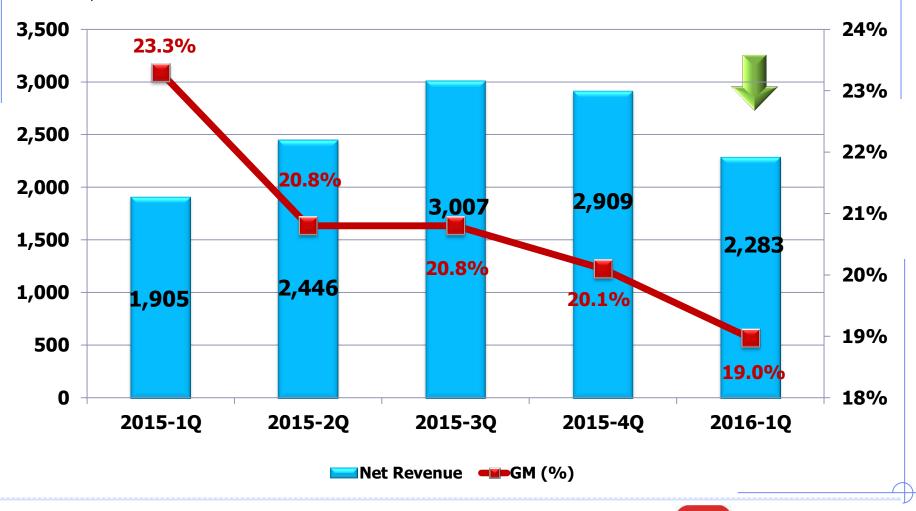

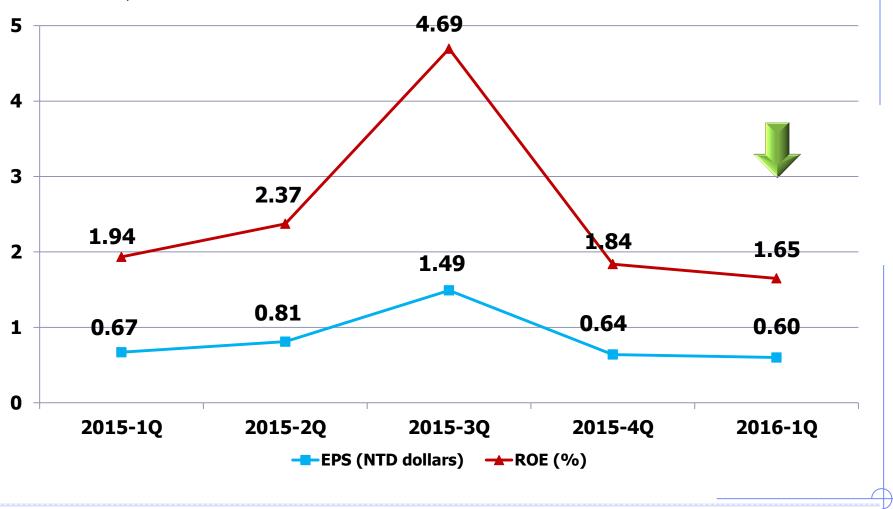
