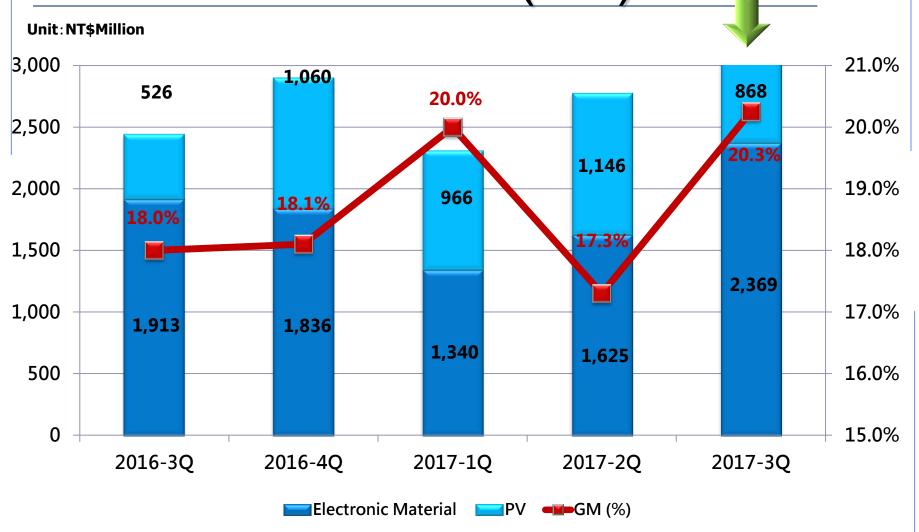

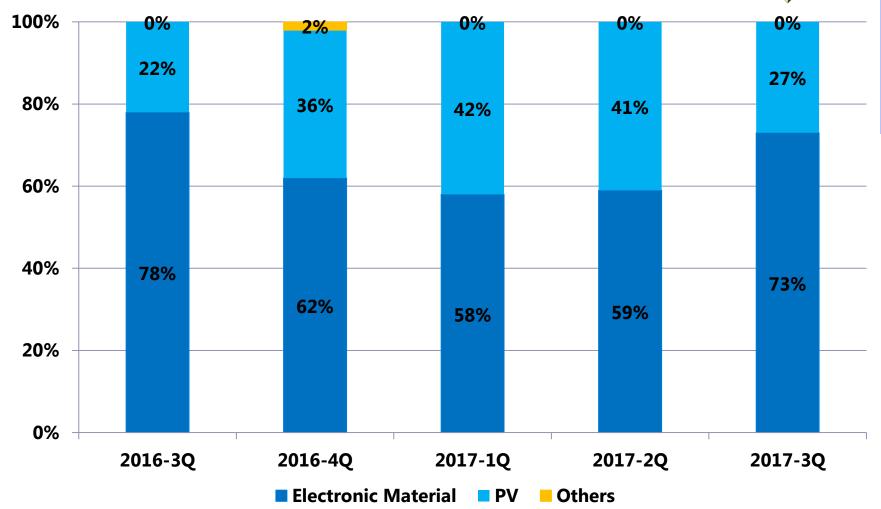
### Sales Breakdown (1/2)
